WHEREAS, on 11 June, 2019 the Town Board of Oxford Township adopted ordinance No. 2019-01 "An Ordinance Regulating Parking and Providing for the Towing of Vehicles from Town Roads" (the "Ordinance");

WHEREAS, it is not practical to publish the entire text of the Ordinance in the Town's official newspaper;

WHEREAS, Minnesota Statute, section 365.125, subdivision 2 allows the publication of a summary of an ordinance instead of publishing the entire ordinance; and

WHEREAS, the Town Board determines publication of a summary of the Ordinance is sufficient to clearly inform the public of the intent and effect of the Ordinance.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby determines to publish the following summary language, which is hereby approved, in lieu of publishing the full text of the Ordinance:

**OXFORD TOWNSHIP  
ISANTI COUNTY, MINNESOTA  
Ordinance 2019-01  
AN ORDINANCE REGULATING  
PARKING AND PROVIDING FOR  
THE TOWING OF VEHICLES  
FROM TOWN ROADS**

The Town Board adopted Ordinance No. 2019-01 to impose parking restrictions that prohibits parking in such a way that violates state law, obstructs a town road, or interferes with the maintenance of a town road. The ordinance also places parking restrictions during the snow season, prohibits placing objects in town roads, and prohibits leaving an abandoned vehicle or junk vehicle on a town road or town property. A copy of the full ordinance is in the Isanti Public Library and is available by contacting the Town Clerk.

BE IT FINALLY RESOLVED, that the Town Clerk is hereby authorized and directed to:

(a) Publish the approved summary language set out above once in the Town's official newspaper;

(b) Keep a copy of the full Ordinance in the office of the Town Clerk;

(c) Place a copy of the full Ordinance at the Isanti Public Library;

(d) Place a copy of the full Ordinance at the Isanti County Law Library; and

(e) Place the Ordinance in the Town Ordinance Book within 20 days together with a copy of the affidavit of having published the approved summary language.
